

Sub: Application seeking information under RTI Act.

Sir,

Most respectfully I submit the following seeking information from your end under the provisions of RTI Act.

The student of some educational institutions forms unions with the objective to work for the welfare of the students as a whole. The functions of the members of the unions are supposed to be strictly confined within the ambit of academic and sports activities. No students union carries any special status other than the welfare of the students in academic matters.

In Assam, the student communities and their Secretary and President are regularly seen to hold processions bands, rail/road blockade, shouting slogans, gheraos against the Government or Private Organizations besides appearing before the media expressing grievances in matters which are not related to their academic carrier.

The entire student communities are found to be aided and advised by outsiders of senior age group who are not connected with any educational institutions. Acting under the umbrella of such advisers, the student community with their Secretary and President got involved deep into matters of politics against the Government Policies, and administrative matters, legal and public issues abstaining from their classes.

There is ample ground to believe that the Department of Higher Education and the authorities of the academic field have appointed adviser/advisers to aid and advise the student community and have also permitted the student community/student unions to take part in various non-academic matters, specially political issues.

Therefore, I seek the following information and copies of document under RTI Act-

1. The copies of orders/circulars/notifications issued by the Department of Education, Government of Assam and Head of any Educational Institution officially appointing adviser/advisers from the members of the public for the purpose of aiding and advising the student communities/student unions as a whole.
2. Copies of the orders/notifications/circulars, sanction order creating the post under the designation of "student adviser/advisers" by the Government of Assam, and/or by the Department of Education, or by the head of any educational institution and more particularly by the authority of the Cotton College, Guwahati for the purpose of aiding and advising the student community/student unions under the leadership of their Secretaries and Presidents and the so called advisors.
3. Under what rule or law or procedure or order the students community under the banner of AASU enjoys the freedom to take to the streets under leadership of the so-called adviser/advisers to organize meetings, processions, dharnas, gheraos, slogans against the state/central government or against any public body/individual in matters falling under political issues as well as in matters falling under

non-academic matters, resulting in diversion of mind and lessening their educational interests? The copies of such rules or orders may be furnished.

4. Whether there exists any rule or law to impose prohibition on the student community in getting involved in such non-academic matters under the leadership of the so-called adviser/advisers? The copies of such rules or orders may be furnished.
5. Under what provisions, rules or order the head of any educational institution permits any student body in association with outsiders to use educational campuses for political or non educational purposes or for holding anti-govt. meetings organized/sponsored by outsiders? The copies of such rules or orders may be furnished.

Since long years, the student unions, by whatever name they may be called, are always seen agitating against all policy and administrative matters pertaining to state and central government. They even compel teenager students to hold processions, bandhs, rail/road blockade, shouting slogans, gheraos against the government or private organizations. They are regularly seen appearing before the media expressing grievances in matters which are not related to their academic carrier.

The entire student communities are found to be aided and advised by outsiders of senior age group who are not connected with any educational institutions. Such advises are only for personal publicity of the advisers. Acting under the umbrella of such advisers, the student community got lured

government policies and administrative matters. Such advisers teach the student community to take-up their classes in the schools which teach agitational techniques as their primary education by boycotting their classes.

Therefore, I seek the following informations under RTI Act-

1. The student community are supposed to seek advises and suggestions from their concerning head of the institutions in respect of any quarries relating to academic matters.

Whether the department of education, government of Assam or head of any educational institution officially appointed any adviser/advisers from the members of the public for the purpose of aiding and advising the student community as a whole?

2. Whether there is any post under the designation of student adviser/advisers ever sanctioned/created by the state government, the department of education or by the head of any educational institution and more particularly by the authority of the Cotton College, Guwahati?



Under what rule or law or procedure or order the students community under the banner of AASU enjoys the freedom to take to the streets under leadership of the so-called adviser/advisers to organize meetings, processions, dharnas, gheraos, slogans against the state/central government or against any public body/individual in matters falling under political issues as well as in matters falling under non-academic matters resulting in diversion of mind and lessening their educational interests?
