
Sir,

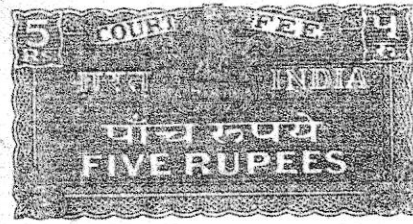
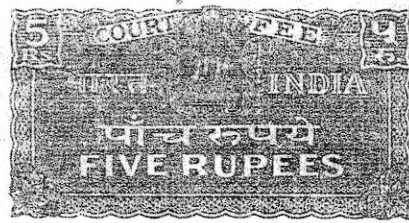
