We are Adivasis-the Indigenous Community of India

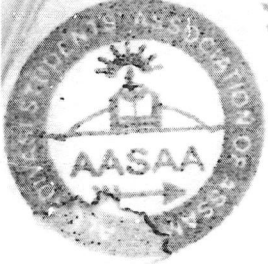

We have our own rich culture, literature and language which has no relation with tea gardens. Our contribution to the development of Assam is much more than any other community. We are indigenous and tribal but we are deprived of the Government recognition and subject to oppression and suppression by the term Tea Tribes and Ex-Tea Tribes. Your Government has failed to do anything or show good intention for the Adivasis.

We the members of AASAA are greatly hurt and feel despised when we termed as Tea Tribes and all the developmental schemes are named in the name of Tea Tribes. We the members of AASAA had supported your party in last elections as Adivasis and not as Tea Tribes.

The All Adivasi Students' Association of Assam[AASAA] would like to state here that the Adivasis of Assam comprises of Santhal, Mundas, Oraons, Kharias, Gonds, Pans, Baraik, Tanti, Prajas, Bheels, Koyas, Bhumij, Ho, Kissans, Paharias, Lohars, and dozens of others are Indigenous-Scheduled Tribes in all over India. The de-scheduling done to Adivasis of Assam during the tenure of Lokpriya Gopinath Bordoloi Government has done irreparable damages to our community's culture, tradition, language and economy.
