

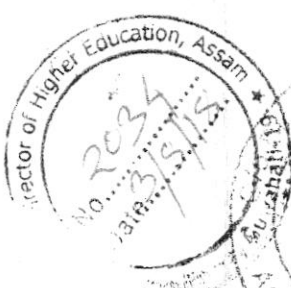
The registration of AISHE portal is open up to 30th September 2018.
