

Sub : Extension of benefit of seniority and CAS promotion on the date of fulfilment of the condition of M.Phil/Ph.D to the founder college teachers appointed against valid sanctioned posts by duly constituted selection committies during the period from 1992 to 1999, by counting their past service.

Subsequent to modification of the Govt of Assam in Higher Education Department OM vide No.AHE.502/2014/38 dated 08-07-2015 by the OM No.AHE.502/2014/ 131 dated 24-05-2018 and the clarification by Govt. letter vide No. AHE.502/2014/134 dated 07-08-2018, it is clarified that the founder college teachers appointed during the period from 1992 to 1999 shall be eligible for seniority and CAS promotion from the date of fulfilment of the condition of acquiring M.Phil/Ph.D by counting their past service in valid sanctioned posts without any financial benefit of arrear claims.
