With reference to Govt. letter on the subject cited above, I have the honour to enclose herewith a Govt. letter bearing No. HLA.672/2007/Pt.-V/10, Dated. 9th January'2018 in connection with request to direct all Educational Institutions across the State to install tobacco prohibitory signage.

In this regard it may also be mentioned here that the cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act (COTPA)2003, is implemented throughout the state of Assam. As per the Section 6 of "Cigarettes and other Tabacco Products Act'2003 Prohibits sale of tobacco products to a person below the age of 18 years and within a radius of 100 yards of any educational institution.

You are therefore, requested to make the rules it mandatory to display and exhibit a board, with a minimum size of 60 cm by 30 cm, in the local language. The board may be installed in common/prominent place(s) outside the premises, prominently stating that "Sale of cigarettes and other tobacco products in an area within a radius of one hundred yards of the education institution is strictly prohibited and that it is a punishable offence."

As you are aware, that the cigarettes and Other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act (COTPA) 2003, is implemented throughout the state of Assam.

As per the Section 6 of 'Cigarettes and other Tobacco Products Act 2003' prohibits sale of tobacco products to a person below the age of 18 years and within a radius of 100 yards of any educational institution.

The Rules make it mandatory that any person in-charge of affairs of the educational institution, to display and exhibit a board, with a minimum size of 60 cm by 30 cm, in the local language. The board may be installed in common/prominent place(s) outside the premises, prominently stating that 'sale of cigarettes and other tobacco products in an area within a radius of one hundred yards of the education institution is strictly prohibited and that it is a punishable offence'.

The radius of one hundred yards of any education institution is to be measured radially, starting from the outer limit of boundary wall/fence, of the educational institution.

In this regard, with reference to the subject cited above, I wish to request you to kindly direct all Educational Institutions to install such boards/wall paint outside the Educational Institutions.

An action in this regard will be highly appreciated.
