

Dear Shri Singh,

Kindly refer to my letter of even No. dated 8th July, 2019 regarding reimbursement of 50% central share by the Central Government to the State Governments for implementation of scheme of revision of pay of teachers and equivalent cadres, based on the recommendations of the 7th Central Pay Commission (CPC), in State Universities and colleges of your State.

2. I wish to inform you again that the State Governments are required to submit complete proposal, as per MHRD's orders dated 26.07.2018 and 11.09.2018, for reimbursement of central share under the scheme. This Department has received several proposals for reimbursement of central share from State Governments. However, as the proposals submitted by some of the States are not complete/ correct as per MHRD's above orders, the central share could not be reimbursed. In view of above, this Department has reconsidered the matter and it has been decided to extend the **last date** by three months i.e. **upto 31.12.2019** for submission of proposals by the State Governments.

3. I would also like to inform you that as per clause 8 of MHRD's order dated 26th July, 2018, **"It shall be necessary for the Universities and Managements of colleges to make appropriate changes in their statutes, ordinances, rules, regulations, etc. to incorporate the provisions of this Scheme and a copy of the same shall be submitted to the Ministry and UGC"**.

4. I request you to look into the matter to expedite submission of complete and correct proposal, along with copies of amended statutes, ordinances, rules, regulations, etc. of State Universities and colleges, for reimbursement of central share, **on or before 31.12.2019**. You are also requested to confirm whether all eligible teachers for 7th CPC have been included in the proposal along with details of posts as per enclosed format.

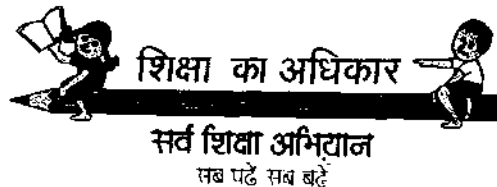
