Sìr,

Reference to the meeting held with PMU of Samarth Portal on 10th Apr 2024 at Institute of Informatics & Communication, University of Delhi to discuss the integration of CSC Connect and CSC Wallet, it is understood that the online student application consists of following steps:

1. OTR – One-time registration of students.

2. Profile Creation - Students will enter/update their personal and educational details along with uploading of relevant documents.

3. Program Selection consisting of preference assignment for College(s)/Subject(s) and form submission.

4. Online Modification involving uploading of correct/ incomplete documents; cancellation of admission offer of a particular college when a student desires to opt for a different college.

All the aforementioned steps needn't happen simultaneously nor need they be done from a single facilitation source. Therefore, it is proposed that when a student approaches a CSC VLE, the CSC Wallet be allowed to be deployed at both submission stages pertaining to Profile Creation and Program Selection (Points 2 & 3 referred above) to allow the CSCs collect the authorized service charges for their facilitation service. The Service charges (excluding any taxes) proposed is Rs. 15/- for a single profile creation and Rs. 15 for every single Program Selection form respectively.

Post submission of Program Selection form, it is decided to not charge the students for any online modifications (Point 4 referred above) if the student desires to again take the facilitation support of the CSCs for the same. CSC Wallet will not be deployed at this stage.

Further, to prevent wrong charging, following interventions are proposed:

- 5. Display of a pop-up message on the home page of Samarth Portal mentioning that specified Service Charges are applicable only when a student takes the facilitation of a CSC; otherwise it is free.
- 6. Display of grievance support desk details in the payment receipts.
