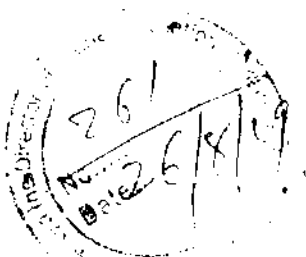

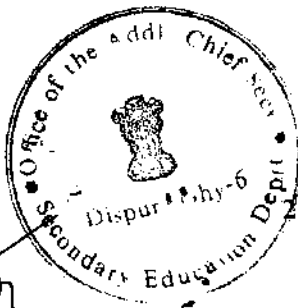

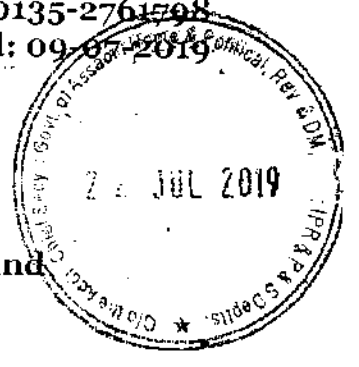

It is to inform you that the CBI, Anti-Corruption Branch, Dehradun has registered two criminal cases against a fake educational board in the name and style of "Board of Secondary Education, Madhya Bharat, Gwalior". These cases have been registered on the basis of a Preliminary Enquiry conducted on the orders of the Hon'ble High Court of Allahabad, Uttar Pradesh. It is alleged that the instant board had issued a large number of fake mark sheets and certificates with/without conducting examinations and solely for the purpose of financial considerations.

During the course of enquiry, it has been revealed that the name of some educational boards which were functional prior to the independence of India including "Board of Secondary Education, Madhya Bharat, Gwalior", inadvertently remained mentioned in the Uttar Pradesh Intermediate Education Act, 1921. The accused persons while taking advantage of this fact have re-established this board by way of Registered Trust Deeds in the year 2010-11. However, after the activities of this board came into light during the year 2011, the Madhyamik Shiksha Parishad, Uttar Pradesh (UP Board) has removed the name of this "Board of Secondary Education, Madhya Bharat, Gwalior" on the ground that "all the boards which were functional prior to independence became invalid and ceased to exist after the establishment of Central Board of Secondary Education in the year, 1952.

During the course of enquiry, it has been further revealed that the Ministry of Human Resource Development, New Delhi; Education Departments of Government of Uttar Pradesh and Madhya Pradesh have neither approved nor recognized any board in the name of "Board of Secondary Education, Madhya Bharat, Gwalior" and has informed that the issuance of mark sheets and certificates by this board is completely illegal as an Educational board which is constituted as per Statute can only issue mark sheets and certificates. Further, the Department of Education, Government of Uttar Pradesh on 05<sup>th</sup> March, 2014 had removed the name of "Board of Secondary Education, Madhya Bharat, Gwalior" from UP Intermediate Education

Act, however, the board is still continuing its operations all over the country. The Ministry of Human Resource Development, Department of School Education & Literacy, New Delhi has informed that "Board of Secondary Education, Madhya Bharat, Gwalior" has neither been set up nor approved nor recognized by MHRD.

It has been further revealed during the enquiry that various States of Republic of India have given equivalence to the examinations of "Board of Secondary Education, Madhya Bharat, Gwalior" in their respective states for the purpose of seeking appointment in different Government/Private Organizations and for taking admissions for higher studies. Further, various schools/colleges of these States have also taken affiliation from "Board of Secondary Education, Madhya Bharat, Gwalior" to conduct examinations of Class - Xth and XIIth and in furtherance are issuing mark sheets and certificates of this board to the candidates. On the basis of these fake mark sheets and certificates, various candidates have procured appointments in Government Departments of Union of India as well as States.

It is therefore, requested that the beneficiaries who have procured appointments in Government Departments in your State on the strength of mark sheets and certificates of "Board of Secondary Education, Madhya Bharat, Gwalior" may be ascertained and suitable action as deemed fit be initiated against them. { Further it is also requested that necessary steps may kindly be taken against the board so that the board should not ruin the future of bonafide candidates/students. } 'x'
