

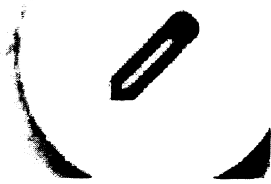

Sub: Assam Services (ROP) Rules, 2010- Date of next increment in revised pay structure under Rule 10 of the A.S. (ROP) Rules, 2010.

In accordance with the provisions contained in Rule 10 of the A.S. (ROP) Rules, 2010, there will be a uniform date of increment viz. 1<sup>st</sup> July of every year. Employees completing 6 months and above in the revised pay structure as on 1<sup>st</sup> of July will be eligible to be granted the increment. The first increment after fixation of pay on 1-1-2008 in the revised pay structure will be granted on 1-7-2008 for those employees for whom the date of next increment was between 1<sup>st</sup> July, 2008 to 1<sup>st</sup> January, 2007.

2 There was no provision for those Govt. employees who were due to get their annual increment between February to June during 2008.

3 On consideration of the above fact and in exercise of the powers conferred in Rule 3 of the A.S. (ROP) Rules, 2010 the Governor of Assam is pleased to decide that in relaxation of stipulation under Rule 10 of these Rules, those State Government employees who were due to get their annual increment between February to June during 2008 may be granted one increment on 1-7-2008 in the pre-revised pay scale as a one time measure and thereafter will get the next increment in the revised pay structure on 1-7-2008 as per Rule 10 of A.S. (ROP) Rules, 2010. The pay of the eligible employees may be re-fixed accordingly.



**GENERAL MEMORANDUM**

Sub : Assam Services (RPF) Rules, 2010 - Date of increment in revised pay structure under Rule 10 of the A.S (RPF) Rules, 2010

In accordance with the provisions contained in Rule 10 of the A.S (RPF) Rules, 2010, there will be uniform date of increment viz. 1<sup>st</sup> July of every year. Employees completing 6 months and above in the revised pay structure as on 1<sup>st</sup> of July will be eligible to be granted the increment. The first increment after fixation of pay on 01-01-2006 in the revised pay structure will be granted on 1-07-2006 for those employees for whom the date of next increment was between 1<sup>st</sup> July, 2006 to 1<sup>st</sup> January 2007.

2. There was no provision for those Govt. employees who had been drawing beyond maximum scale of pay on 01-01-2006 and their 2<sup>nd</sup> and 3<sup>rd</sup> stagnation increment as the case may be due between February to December during 2006.

3. On consideration of the above fact and in exercise of the powers conferred in Rule 8 of the A.S (RPF) Rules, 2010 the Governor of Assam is pleased to decide that in relation of application under Rule 10 of these Rules, those State Government employees who had been drawing beyond maximum scale of pay on 01-01-2006 and their 2<sup>nd</sup> and 3<sup>rd</sup> stagnation increment as the case may be due between February to December during 2006 would also be taken into account for fixation of pay on 01-01-2006 in terms of Rule 10 of A.S (RPF) Rules, 2010.
