OFFICE MEMORANDUM

It has been observed that many proposals have been received for Government concurrence of different subjects of Provincialised Colleges and Venture Colleges of Assam.

The Assam Venture Educational Institutions (Provincialisation of Services) Act, 2011 and the Assam Education (Provincialisation of Services of Teachers and Re-Organisation of Educational Institutions) Act, 2017 mentions "Concurrence" as main eligibility criterion since only those Colleges having Concurrence received upto 01-01-2006 are eligible for provincialisation under Section 3(1) of the aforesaid Act.

Now, Govt. of Assam in Higher Education Department is pleased to notify that no Concurrence to subjects shall henceforth be given. Govt. will create posts on individual merit for Provincialised Colleges for subjects etc.

However, NOC for opening of new colleges will be required. In this regard, proposal for NOC is to be submitted by Director of Higher Education, Assam to the Government.

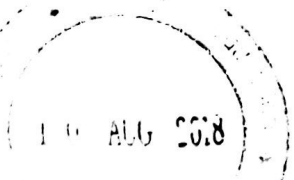


