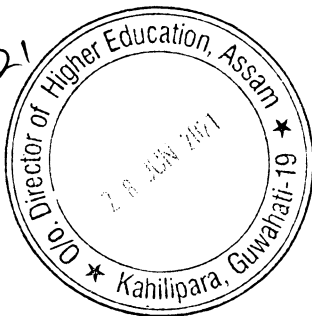

Dear Colleagues,

With reference to my earlier communication, I am to urge you to ensure that your administrative Department submit all the requisite reports including Scheme wise Annual monthly calendar and action taken report. I am told some departments are yet to submit the same. I once again request you to kindly furnish reports at the earliest.

It is a matter of serious concern that in a large number of Central schemes, Assam is not availing of second instalment. In a number of cases even the first instalment is not being availed of.

Under the circumstances, you are requested to submit the action taken report before 10th April, 2021 after due attention to the 2021 – 22 Union Budget provisions together with corresponding GOI Ministry website for schemes. You are also requested to examine and take needed steps so that Assam Budget too provides similar allocation for each of the central scheme in its own budget for expenditure including Supplementary Demand arrangements. Administrative Departments and Finance Department should work jointly for the purpose.

Once again I request you to submit the requisite reports error free and complete in all respects to Monitoring Division in compliance with decisions taken in the 24th September 2020 review meeting immediately and also submit the action taken report on or before 10th April, 2021.
