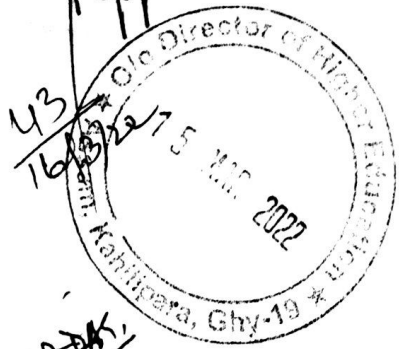

I have the honour to state that process of filling up of posts reserved for Persons with Disabilities under Grade-IV category have already been initiated through the State Level Police Recruitment Board (SLPRB) and later been entrusted to the Gauhati University. The Gauhati University has already conducted the selection process and is in the process of declaring the results for the same.

It is further informed that under Grade-IV, a total of 513 posts were advertised as per vacancies identified by the various Departments. Out of these 513 posts, 140 posts were earmarked for persons with Low vision/ blind; 184 posts were earmarked for Hearing Impaired category; and 189 posts were earmarked for Orthopaedically handicapped category. The posts reserved for Persons with Disabilities identified by the various Departments are enclosed as Annexure-I, II and III.

In this context, Departments are requested not to include these posts, for which the selection process is ongoing, in the proposed vacancies for recruitment by the newly constituted Commission.
