- 2) Whether they subsequently fulfilled their requisite conditions in the stipulated time period as stated in their appointment letter? (Furnish Photocopy copy of their appointment letter)
- 3) In case of M.Phil used for waiving off conditions furnish the following points.
 - a) Date of award of M.Phil degree and the name of University that awarded it.
 - b) M.Phil Registration Number and Date.
 - c) Photocopy of Migration Certificate submitted to the University.
 - d) Whether the course was Regular or Distance mode
 - e) Procedure details adopted by the awarding University for selection of M.Phil scholars.
 - f) Total number of seats and degrees awarded by the concerned University during the session in which such teachers got their degrees awarded.
