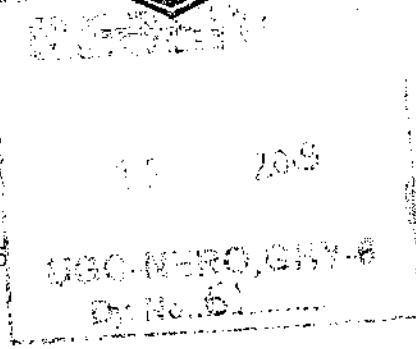





In response to so far as USL Section 6(3) of the act, regarding information sought under No. 6/1 and 6/2 raised in cited RTI application is as under.

Points 6&7: Sarvatra Shiksha - an Integrated Scheme for School Education has been launched throughout the country as a Centrally Sponsored Scheme with effect from the year 2018. The programme subsumes the three erstwhile Centrally Sponsored Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE). It is an overarching programme for the school education sector extending up to class XII. It aims to ensure inclusive and equitable quality education at all levels of school education. It envisages the 'school' as a continuum from pre-school, or 'anganwadis', primary, secondary to senior secondary levels. This scheme doesn't make discrimination against students in any manner especially sex or prevented them from pursuing and completing education from pre-nursery to class XII.

Point 8: Information is not available in this section. As the matter is connected with college which is dealt to D/o Higher Education, therefore, the RTI application is being transferred to US(Language and CPIO), D/o Higher Education under Section 6(3) of the RTI Act, 2005 with request for providing information directly to you.
